In executing this Waiver and Release of All Claims, I hereby agree and acknowledge that I am utilizing the premises and engaging in horseback riding and/or horse-drawn vehicle at my own risk, and that I recognize the specific danger inherent in horseback riding and/or horse-drawn vehicle to me and/or my minor child (ren) arising from approaching, handling, mounting, riding and dismounting the horse or horse-drawn vehicle and I fully understand and appreciate that horseback riding and/or horse-drawn vehicle can be a hazardous activity for participants as well as by-standers of any age, and could result in serious or even catastrophic injury, including the risk that TTR or its servants, agents or employees may act negligently in selection, preparing or maintaining the horse(s), vehicle(s), equipment or premises, in assisting me and /or my minor child(ren) to mount or dismount from the horse or horse-drawn vehicle, or otherwise supervising the activity.
